3. The promotion of the executives at para 1 and 2 above is further subject to the conditions that no disciplinary / vigilance case is pending against the executives on the date of assumption of the charge. In case any disciplinary / vigilance case of the type referred to in D.O. P&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 is pending against the executive or some punishment like stoppage of increment etc. is current, he/she should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office immediately.

4. Before implementation of these order(s) in respect of executives mentioned in para 1 & 2 above, the Circle(s) must ensure that Presidential orders for absorption of the executives in BSNL have been issued and executives to be promoted are working in the grade of STS on ad-hoc basis in the circle. Any other discrepancy, viz name of the executives, staff no, category etc shown in the orders varies may be brought to the notice

of BSNL CO with supporting documents for rectification of records. Moreover, if the executives are not working in the respective circle shown against them, the orders should not be implemented, but the executives relieved immediately with direction to report to the circle of posting shown against him and the matter should be reported to CO BSNL Any request for declination of promotion / modification of place of posting on promotion will not be entertained at present by the management due to administrative exigencies.

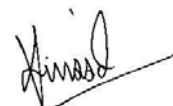
5. On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009. In respect of Sr. AO now promoted to STS on regular basis, his pay will be fixed in accordance with the instructions contained in the order no. 400-61/2004-Pers I dated 18.1.2007 read with O M no. 1-50/2008-PAT (BSNL) dated 5.3.2009.

7. All the IFAs may check up the up-to-date position regarding the vacancies in the grade of STS in their circles after implementation of the above order and intimate the same to SEA Section, CO BSNL, New Delhi.

8 After promotion to STS grade on regular basis, the seniority of the executives in the grade of STS in Telecom Finance will be communicated subsequently which will be based on the date of promotion to the grade of Accounts Officer on regular basis, as per guidelines contained in BSNLMS RR 2009 and EPP 2007 guidelines and further modifications issued from time to time.
