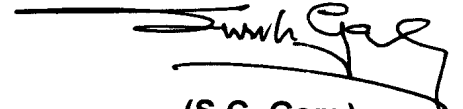

OFFICE MEMORANDUM

Subject: - Final Seniority List in the grade of Executive Engineer (Civil) of P&T Building Works (Group A) Service.

The final seniority list in the grade of Executive Engineer (Civil) was last issued vide OM No.33-2/2003-CWG dated 12.4.2004. The seniority list was subject to final outcome of SLPs in the matter of Shri D.K.Vijh v/s UOI (CA No.7352/2002); Smt. Nasreen Quadri v/s UOI (CA No.4484/2003), Shri R.N.Khurana v/s UOI (CA No.24096/2003) and W.P.No.17603 of 2001 pending in Hon'ble High Court, Madras.

2. Hon'ble CAT, Chennai Bench in its order dated 12.07.2001 set aside DOT order No.3-1/98-CWG dated 16.01.2001. The judgment of CAT, Chennai was upheld by the Hon'ble High Court, Madras vide their order dated 17.8.2006 in WP No.17603 of 2001. In pursuance of the judgment of Hon'ble High Court, Madras, DOT Order No.3-1/98-CWG dated 16.01.2001 has been cancelled and the position of Executive Engineers(C) from the stream of AE(C) on the basis of the recommendations of DPC held in 1997 restored vide Notification No.19-21/2006-CWG dated 10.05.2007. Accordingly in the seniority list of 2004 the position of Gr. B officers as per notification dated 10.5.2007 have been changed without affecting the position of Group-A officers within their quota and a provisional seniority list was issued on 13.6.2007. Implementation of judgment of Hon'ble CAT, Chennai/ Madras High Court necessitated review of the DPC held in 2003 for promotion to the grade of EE(C) from the stream of AE(C) under Group "B" quota. The review DPC was held on 16.1.2009 and the revised panel was issued vide Order No. 3-1/2002-CWG (Pt.) dated 2.3.2009.

3.1. Hon'ble CAT, Jaipur in their order dated 18.4.2002 in OA No.245/96 in the matter of Shri R.N. Khurana Vs. UOI has directed that Shri Khurana, is entitled to be treated on regular basis from 1978 and is also entitled to be considered for further promotion to the post of SE(C) from the date his junior was so promoted, with all consequential benefits. The judgment of Hon'ble CAT, Jaipur was upheld by Hon'ble Rajasthan High Court. The SLP filed by the department in CA No.24096/2003 and Review Petition No.954/2004 was dismissed by the Hon'ble Supreme Court.

3.2 In OA No.1689/2000 filed by Shri D.K.Vijh in CAT, New Delhi the Hon'ble CAT has ordered to treat the applicant as regular in the grade of EE(C) w.e.f. the date of his ad hoc promotion and considering his case for promotion as SE(C) from the date on which his junior was promoted as SE(C). The decision of the Hon'ble Tribunal was upheld by the Hon'ble Delhi High Court. Hon'ble Supreme Court in their judgment dated 8.5.2008 in SLP (CA NO.7352/2002) set aside the orders of the Tribunal and Delhi High Court.

3.3. In O.A. No. 1176 of 1999 filed by Smt. Nasreen Quadri, Hon'ble CAT, Hyderabad in order dated 8.3.2001 held that the applicant is entitled for deemed promotion with retrospective effect from the year of selection i.e. 1988 on notional basis and the said date is to be taken into consideration for counting the qualifying period of 5 years for promotion as SE(C). The decision of the Hon'ble Tribunal was upheld by the Hon'ble High Court, Hyderabad. The SLP filed by the department in CA No.4484/2003 was dismissed by the Hon'ble Supreme Court in their judgment dated 20.01.2009

4. The seniority list has been prepared taking into consideration the directions of Hon'ble Courts and keeping in view the provisions in the Recruitment Rules and the general principles of seniority laid down in OM NO.9-11/55-RPS dated 22.12.1959 further clarified by DOP&T OM No.22011/7/86-Estt(D) dated 3.7.1986, No.20020/4/89-Estt(D) dated 07.02.1990. In this list the names of Executive Engineer(Civil) who were regularized under the Initial Constitution Clause for Recruitment Rules 1976 i.e. upto Sl. No.54 have been placed en-block senior in accordance with the provisions in the amended Rules dated 05.04.1980. Thereafter, the officers promoted from the two feeder grades to the grade of Executive Engineer (Civil) after 25.9.1976 have been placed in accordance with the rotation of vacancies between AEE(C) and AE(C) on the basis of quota 2 : 1 as prescribed in the Recruitment Rules upto 06-08-1994 as per 1976 Recruitment Rules [91 Gr. 'A' : 45 Gr.'B'] and 1:1 after 06.08.1994 as per 1994 Recruitment Rules [65 Gr.'A' : 65 Gr.'B'] . The position of Group-A officers is as per UPSC merit and subsequent regular promotion as Executive Engineer (Civil) and in case of Group B officers, is as per their position in the UPSC select list of 1997 DPC and 2009 review DPC.

5. The representations received on the provisional seniority list dated 13.6.2007 have been duly examined keeping in view the directions of Hon'ble Courts and the provisions in the Recruitment Rules and relevant instructions of nodal Ministry i.e. DOP&T. Similar issues were raised against the provisional seniority list of EE(C) issued in 2003 which was examined before finalization of EE(C) seniority list 2004. After carefully examining the objections, the seniority list has been finalized. A copy of the seniority list is enclosed herewith for circulation to all concerned.

6. In the seniority list, at some places, the officers from Group 'A' cadre have been shown bunched together considering the retired officers who were empanelled for promotion by the Review DPC held on 16.1.2009.

7. This seniority list includes names of only those officers promoted to the grade of Executive Engineer (Civil) upto 12.4.2004. This seniority list is to be trifurcated based on the officers' present status in the respective organization i.e. BSNL/MTNL/DOT. Officers promoted to the grade of EE(C) after 12.4.2004 are to be placed in the seniority list accordingly by the respective cadre controlling authority as per relevant rules/instructions on the subject.

8. The seniority list is subject to the outcome of any case pending on this issue in any Bench of the CAT or the High Court in India.

This issues with the approval of competent authority.
