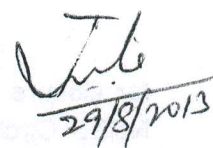
Subject: Closure of NCES Circle – Creation of National Centre for Next Generation Network (NCNGN) Circle by renaming NCES Circle

Approval of the Management Committee of BSNL Board is hereby conveyed for closure of NCES Circle and simultaneous creation of NCNGN Circle by renaming the NCES Circle. The terms and conditions of the closure of NCES Circle and simultaneous creation of NCNGN Circle by renaming the NCES Circle are as under:

- i. The new circle NCNGN (National Centre for Next Generation Network) Circle is hereby created. The newly created NCNGN circle will utilize complete infrastructure and establishment of the erstwhile NCES Circle.
- ii. All the Officers and Staff presently posted in the erstwhile NCES circle stand transferred to the NCNGN Circle and its Regional Offices at the same stations.
- iii. NCNGN Circle would be responsible for NGN Network and would be responsible for handling the complete NGN networks including commissioning and coordination during installation & testing phase, directly managing O&M of Core sites, providing second line maintenance support to all access nodes and handling technical requirements of IP based switching N/W. In addition, technical interface/ integration requirements of LMGs may also be facilitated by this circle in co-ordination with IP/MPLS and Broadband Circle. The focus of the Territorial Circles should mainly be on managing the access nodes and serving customers. The NCNGN Circle would be under the overall charge of Director (CFA), BSNL Board.
- iv. The NCNGN Circle would also be responsible to perform the residual functions of NCES viz. performing co-ordination and monitoring functions relating to E-10B systems and second line maintenance support of NT switches and C-DoT MAX. In due course, the NCNGN Circle may be entrusted with the responsibility of second line maintenance of class 4 NGN.

- v. Location of the Headquarters for NCNGN Circle will be at New Delhi with the same establishment of the erstwhile NCES circle.
- vi. The Regional Centres of the erstwhile NCES will now act as the Regional Centres of NCNGN Circle at the same location and with the same infrastructure and officers/staff.
- vii. The requirement of additional officers and staff for NCNGN circle, if any dependant on the workload, would be met from the respective Circles/SSAs in which the NCNGN or its Regional Centres are located with existing office set up and other infrastructure.

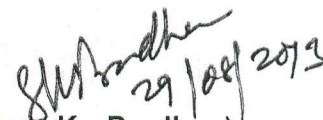
