**Sub.: Promotion of JTO (Civil)s to the grade of SDE(Civil) on the basis of Limited Departmental Competitive Examination ( 33 % quota) held on 10.08.2008.**

Pursuant to BSNL CO's office letter No. 30-1/2009-DE(1) dated 08-07-09, even number dated 10-07-09, No.63-9/2010-DE dated 23-03-2010, 30-1/2009-DE dated 09.4.2010, 63-15/2010-DE dated 05-05-2010, 63-42/2010-DE dated 29.05.12, No. 63-07/2014 - DE dated 07-05-2014 and No.30-1/2009-DE dated 05.03.2015, the competent authority is pleased to promote following JTO(Civil) to the grade of SDE(Civil) on the basis of Limited Departmental Competitive Examination ( 33 % quota) held on 10.08.2008 in the Pre- revised IDA pay scale of Rs.11875-300-17275 and is allocated to BSNL Civil Zone as under:

2. The promotion of the executive shall be subject to the following conditions :

(i) Deemed date of his notional promotion in the grade of SDE(C) will be the date on which his juniors in the grade of JTO(C) were given promotion i.e. 10.05.2010.

(ii) Pay of the executive shall be fixed on actual promotion i.e. from the actual date of assumption of charge of the higher post at the stage, he would have reached had he been promoted on the deemed date of notional promotion but no arrears would be admissible.

(iii) The Seniority of Shri Krishna Kumar will be fixed at SN 37A i.e. below Shri Sh. Sunil Kumar Srivastava (SN37) and above Shri S K Kulkarni (SN 38).

(iv) The period from deemed date of notional promotion and prior to actual promotion shall be reckoned towards the qualifying period of service for the purpose of eligibility for promotion in the next higher grade.

3. The above order are further subject to the conditions laid down in the DoP&T OM No. 22011/4/91-Estt(A) dated 14.09.1992 viz the executive is under suspension or disciplinary proceedings are pending or prosecution for criminal charge is pending or the executive is undergoing punishment, then the promotion order in respect of the executive shall not be implemented without obtaining the specific approval of this office. Information in this regard may be brought to the notice to this office forthwith.

4. The particulars of executive as mentioned above be checked vis-à-vis the details of executive declared successful by DE Section BSNL CO and any discrepancy shall be got reconciled before effecting the orders.

5. The aforesaid promotion order is subject to the outcome in OA No.316/CH/2010 filed in the Hon'ble CAT Chandigarh Bench and lawsuit(s) pending before any court(s) in connection with subject LDCE 2008 in this regard.

6. The above mentioned promotion shall be effective from the date assumption of charge of higher post.

7. The specific posting orders for the above executive shall be issued immediately by respective zonal PCE(C) / CE(C) after considering standing instructions in respect of posting on sensitive/ non-sensitive posts by competent authority.

8. The executives shall be relieved immediately only on receipt of specific posting orders by making local arrangements if necessary.

9. No leave shall be granted to the above Executives unless he join his new place of posting.

10. Assumption of Charge report may be furnished to all concerned and necessary entries be made in HRMS package/ ERP/ Service Book.
