Sir,

We would like to draw your kind attention towards a letter reported to have been written to you by former Circle Secretary of this association claiming that "AIBSNLEA and AIBSNLOA Chennai TD Circle held joint CEC meeting on 10.12.2014 at Chennai and decided to merge AIBSNLOA with AIBSNLEA." **The Constitution (Memorandum/Rules & Regulations) of AIBSNLOA, which is registered under Societies Registration Act 1860, does not empower any circle executive committee meeting to do so. Such decision can be taken only by the highest forum viz. the All India General Body Meeting.** Therefore what has happened is only the Circle Secretary of AIBSNLOA Chennai Telephones quitting the organization and joining another association.


